





















Potrivit prevederilor art. 485 alin (1) litera f) din Legea nr. 227/2015 privind Codul fiscal cu ultima actualizare - Legea nr. 358 din 31 decembrie 2015, „persoanele cu handicap grav sau accentuat, persoanele încadrate în gradul I de invaliditate și reprezentanții legali ai minorilor cu handicap grav sau accentuat și ai minorilor încadrați în gradul I de invaliditate sunt scutiți de plata impozitului pe clădirea de domiciliu și pe terenul aferent acesteia, precum și de plata impozitului pe autoturism”.

Prin această propunere, considerăm că se face dreptate persoanelor cu handicap grav sau accentuat și aparținătorilor acestora care în prezent nu pot beneficia de prevederile Noului Cod Fiscal.
