


**Legea nr. 144 (r1) din 21/05/2007** in actuala forma nu isi poate atinge obiectivele deoarece:

1. Nu obliga la declararea averilor toate persoanele care, prin pozitia pe care o ocupa in aparatul de stat, constituie factori de decizie importanti si pot castiga ilegal averi contribuind la sporirea coruptiei
2. Nu obliga la declararea averilor conducerele sindicatelor care prin pozitia ocupata pot castiga averi nejustificate si ascunse membrilor de sindicat.
3. Nu obliga la declararea transparenta a veniturilor. Sunt cazuri in care anumiti angajati cu salarii enorm de mari scriu la venituri: „conform fisei fiscale”. Fisa fiscala este un document cu caracter personal la care are acces doar un numar limitat de persoane.

Modificarea legii in sensul propus reduce posibilitatea ca anumiti angajati sa acumuleze averi nejustificate prin trafic de influenta si eludarea legilor.





















