

EXPUNERE DE MOTIVE


OUG 103/2013 prevede la art.9 (1) ca in anul 2014, munca suplimentara efectuata peste durata normala a timpului de lucru de catre personalul din sectorul bugetar (...) precum si munca prestata in zilele de repaus saptamanal, de sarbatori legale si in celelalte zile, in care in conformitate cu reglementarile legale in vigoare nu se lucreaza (...) se compenseaza doar cu timp liber corespunzator.

In sistemul de sanatate si in toate sectoarele bugetare in care este imposibil sa intrerupi activitatea vor fi numeroase consecinte negative:

1. Neplata orelor suplimentare intr-un sistem cu deficit de personal va duce la imposibilitatea asigurarii continuitatii activitatii medicale in ture si garzi.

3. Neplata orelor suplimentare si volumul ridicat de munca in conditiile depopularii sistemului sanitar afecteaza viata privata si sanatatea si scad motivatia celor ce nu au plecat inca din sistem.
4. Neplata orelor suplimentare duce la accentuarea depopularii sistemului de sanatate crescand timpii de interventie si riscul de eroare medicala si malpraxis.
5. Neplata orelor suplimentare si reducerea veniturilor influenteaza negativ si consumul si relansarea economica.

Proiectul meu de act normativ abroga acest articol urmand ca garzile si orele suplimentare sa se faca asa cum este prevazut in codul muncii la art.123.





















